To apply for work in the Catering Department as a **Permittee**, an applicant must provide proof of the following. Please check off which qualifications you possess and include this form, along with your application.

- A valid Safe Food Handling Course Level 1
- Set Etiquette course (Film Training Manitoba: 204-989-9669)
- Proof of Current WHMIS Instruction/Training

The Department also recommends the completion of the following 2 courses, which are available through Film Training Manitoba (FTM):

- Propane Safety
- Transportation of Dangerous Goods (TDG)

Each application must include:

- A completed Permittee Application form (specify which category you are applying for)
- This sheet with your qualifications checked off
- A resume (specify dates, number of days worked, job duties, supervisors)
- Photocopies of all documents/educational certificates listed on the reverse
- A list of any equipment, vehicles, or First Aid Kits you may have
- \$50 processing fee

If you are accepted as a Permittee, it is your responsibility to keep your Resume up to date as well as your correct address and phone number on file at the Union Office. Any person without current information on file will be removed from the roster.

Specific Requirements/Minimum Qualifications:

Permittee Status – the applicant must possess all of the following:

- Related experience as a Cook, Chef or Caterer
- Experience in the Motion Picture Industry
- Set Etiquette course
- Proof of Current WHMIS Instruction/Training
- Food Handler Certificate

Crossover (Inter-Department listing) – the applicant must also possess all of the following:

- 60 days work experience in Catering under Local 856 Collective Agreements
- Set Etiquette course
- Proof of Current WHMIS Instruction/Training
- Food Handler Certificate
- Letters of recommendation from 1 Local 856 Catering department Key & 1 Local 856 Catering department Member

Membership – the applicant must also possess all of the following:

- 60 days work experience in Catering under Local 856 Collective Agreements
- Set Etiquette course
- Proof of Current WHMIS Instruction/Training
- Food Handler Certificate
- Basic First Aid
- Letters of recommendation from 1 Local 856 Catering department Key & 1 Local 856 Catering department Member
