- b) 2 letter of recommendation from 2 keys or 1 key & two full members. All recommendations must come from the Grip Department
- c) Set Orientation
- d) WHMIS
- e) Basic First Aid
- f) Recommendation – applicants should possess the following which are available from Safety Services Manitoba – 204-949-1085 or online at www.safetyservicesmanitoba.ca:
 - i. Lift certificate
 - ii. Fall Arrest Course

Cross-Over (Inter-Department Listing) – the applicant must possess the following:
