- A valid Class 5 Licence (minimum)
- Proof of **Set Etiquette Course** (Contact Film Training Manitoba at 989-9669 for details)
- Proof of Current **WHMIS** Instruction/Training (Contact Film Training Manitoba at 989-9669 for details)
- A current driver's abstract
- First Aid (recommended, may become mandatory)

Please note that **a copy of each document must be included with your application.**
(Please bring your licence and abstract to the office along with your application.)

The applicant must be in good physical condition as there may be heavy lifting involved. The applicant must have extensive driving experience as you may have to operate the following:

- 5 ton trucks
- 15 passenger vans
- Class A motor homes
- Boats
- Snowmobiles
- 1 ton cube vans
- Towing other vehicles
- Motorcycles
- Very expensive picture vehicles
- Tow Truck experience
- Mechanical Skills
- Knowledge of Car Club People and Collectors – mandatory for Picture Vehicles

In addition, good people skills are required, as you will be dealing with a wide range of personalities and people. Each application must include:

- A completed Permittee Application form
- Qualification Form
- A current resume
- Photocopy of educational certificates & licences listed
- \$50.00 processing fee

Specific Requirements/Minimum Qualifications:

Membership – Applicants for Membership must demonstrate all of the following:

- 1 Set Etiquette course
- 2 Proof of Current WHMIS Instruction/Training
- 3 Basic First Aid
- 4 Valid Class 5 drivers license & drivers abstract
- 5 60+ days working on a minimum 2 IATSE Local 856 productions in the department applying for
- 6 Letters of reference from 2 different IATSE Local 856 Picture Vehicle Coordinators

Department Transfer – Applicants for Department Transfer must demonstrate the following:

- 1 Set Etiquette course
- 2 Proof of Current WHMIS Instruction/Training
- 3 Valid Class 5 Drivers License & Driver's Abstract (a copy must be provided along with Application)
- 4 60+ days working on a minimum of 2 IATSE Local 856 productions in the department applying for
- 5 Letters of recommendation from 2 different IATSE Local 856 Picture Vehicles Coordinators

Members Upgrading – Members wishing to upgrade their classifications must demonstrate the following:

- 1 Minimum of 60+ days working on a minimum of 2 IATSE Local 856 productions in the department (and in the position) applying for
- 2 Valid Class 5 Drivers License & Driver's Abstract (a copy must be provided along with Application);
- 3 Letters of recommendation from 2 IATSE Local 856 Picture Vehicle Coordinators (If upgrading to the Picture Vehicle Coordinator, 2 letter of reference required from Producers or Production Managers)
