



HAIR DEPARTMENT QUALIFICATIONS

Thank you for your interest in the Hair Department of IATSE Local 856. Please take a few moments to read the following and assess your qualifications before filling out an application.

To apply for **Permittee** status in the Hair Department, an applicant must provide proof of the following. Please check off any of the following you possess and include this form along with your application:

Hairstylists

- Valid licence to practice Hairdressing in the Province of Manitoba (copy of license required for file)
- Three years of current Salon experience after receiving their Hairdressing License (training positions may be available for those who are **at least** a 2nd year Apprentice Hairstylist)
- Proof of a Set Orientation course (Film Training Manitoba at 989-9669)
- Intro to Paper course (Film Training Manitoba)
- In addition, good people skills are required, as you will be dealing with a wide range of personalities and people.
- Proof of Current WHMIS Instruction/Training (Film Training Manitoba at 989-9669)
- Possess a kit meeting the minimum requirements (**see over for list**)

Wigs – requires all of the requirements of a Hairstylist PLUS

- Wig building course by a recognized Wig Maker
- Proof of a minimum of 2 years of experience in theatre, film, T.V., commercials or a related field as a Wigmaker

Permittee Applications can take time to process. You will be notified as soon as your application has been reviewed. Should you be accepted as a Permittee in the Hair department of IATSE Local 856, you may be required to participate in additional training programs.

Please add all special skills, copies of education certificates or course completions you'd like, in order to showcase your talents.

A Driver's license is strongly recommended but not required, as transportation is not provided. Mode of transportation is solely up to the Permittee and/or member.

Membership – Applicants for Membership must demonstrate all of the following:

- Minimum of 60 days working on a minimum of 2 IATSE Local 856 productions in the department (and in the position) applying for;
- Letters of recommendation from 2 Heads of Department. All letters of recommendation must be from members within the Department you are applying to.
- Valid licence to practice Hairdressing in the Province of Manitoba (a copy must be provided along with Application);
- Set Orientation & Intro to Paper course
- Proof of Current WHMIS Instruction/Training.
- Basic First Aid
- Collective Agreement and Health & Welfare Seminar
