Should you be accepted as a Permittee in the Hair department of IATSE Local 856, you may be required to participate in additional training programs. Please add all special skills, copies of education certificates or course completions you hold, in order to showcase your talents. In addition, good people skills are required, as you will be dealing with a wide range of personalities and people. A Driver's license is strongly recommended but not required, as transportation is not provided. Mode of transportation is solely up to the individual.
